

## **Privacy Policy**

TSO-DATA GmbH respects your concerns about how we use the personal and company information we collect from you through our app and through other methods of communication. This privacy policy describes how TSO-DATA GmbH ("TSO") collects, uses and shares personal information of users of this app. This privacy policy was last revised on: 20 March 2017.

### **Information we collect**

TSO may collect information about you in the following ways:

#### **Information you give us**

TSO collects your name, job title, company name, postal address, email address, phone number, fax number, username, password, personal and company demographic information (such as your company software application, version, user usage, gender and occupation), and any other information you provide to us with our app.

#### **Information we get from others**

TSO may get information about you or your company from other sources. TSO may add this to information TSO gets from this app.

### **Use of personal information**

TSO uses your personal information as follows:

- TSO uses your personal information to operate, maintain, and improve our sites, products, and services.
- TSO uses your personal information to respond to comments and questions and provide customer service.
- TSO uses your personal information to send information including confirmations, invoices, technical notices, updates, security alerts, and support and administrative messages.
- TSO uses your personal information to communicate about promotions, upcoming events, and other news about products and services offered by us and our selected partners.
- TSO uses your personal information to link or combine user information with other personal information.
- TSO may use your personal information to protect, investigate, and deter against fraudulent, unauthorized, or illegal activity.
- TSO uses your personal information to provide and deliver products and services customers request.

### **Sharing of personal information**

TSO may share personal information as follows:

- TSO may share personal information with your consent. For example, you may let TSO share personal information with 3rd parties for their own marketing uses. Those uses will be subject to those 3rd parties' privacy policies.
- TSO may share personal information when TSO does a business deal, or negotiate a business deal, involving the sale or transfer of all or a part of our business or assets. These deal can include any merger, financing, acquisition, or bankruptcy transaction or proceeding.
- TSO may share personal information for legal, protection, and safety purposes.
- TSO may share information to comply with laws in the countries where we operate.
- TSO may share information to respond to lawful requests and legal processes.
- TSO may share information to protect its rights and property, and that of its agents, customers, and others. This includes enforcing our agreements, policies, and terms of use.
- TSO may share information in an emergency. This includes protecting the safety of our employees and agents, our customers, or any person.
- TSO may share information with those who need it to do work for us.

- TSO may also share aggregated and/or anonymized data with others for their own uses.

To the extent TSO and others have mutually executed non-disclosure agreements in effect then certain data collected from this app will not be covered by such agreements.

TSO has implemented physical, electronic, and managerial procedures to safeguard and secure the information collected.
